Memorandum of Understanding

Between

**Università Ca' Foscari Venezia
and
Chukyo University**

Università Ca' Foscari Venezia, henceforth Ca' Foscari, represented by the Rector, Prof. Michele Bugliesi, located in Venice, Italy, Dorsoduro 3246

AND

Chukyo University, henceforth Chukyo, represented by the President, Prof. Hitoshi Yasumura, located in Nagoya, Japan, Yagoto Honmachi 101-2

(hereinafter named THE PARTIES)

Considering that both parties acknowledge the importance of establishing cultural and scientific relations between higher education institutions belonging to different countries in order to achieve their institutional aims

Considering that they have areas of common interest and similar academic goals in teaching and research, have decided to establish the following Memorandum of Understanding (hereinafter referred to as MOU).

Article 1

The Parties agree to exchange information on their respective academic programmes and research activities, for the purpose of facilitating some, or all, of the following:

1. Student Mobility
 - exchange of students;
 - study abroad programmes and summer schools;
 - language training;
 - internships.
2. Joint Programmes
 - collaboration on the training of students through joint academic programmes;
 - co-supervision of doctoral theses.
3. Knowledge Transfer
 - exchange of publications and other academic materials;
 - exchange of academic staff for teaching;
 - conferences and seminars;
 - exchange of administrative staff.
4. Research Collaboration
 - exchange of faculty members, graduate students and postdoctoral fellows;
 - development of collaborative research;
 - joint research programmes;
 - collaborative scholarly publications.

Other cooperation opportunities can be jointly agreed upon by the Parties in the future.

Article 2

For the implementation of each programme or activity among those outlined above, the Parties hereby agree to draw up a separate agreement and to implement the programme or activity within the framework of the rules and regulations of both Parties, and subject to availability of funds and resources of each.

Article 3

The Parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MOU.

At Chukyo, the coordinator will be Dr. Yukio Hiyama
At Ca' Foscari, the coordinator will be Dr. Dorit Raines

Article 4

This MOU will not give rise to any financial obligation by one Party to the other. The Parties acknowledge that in the absence of any specific agreement in writing to the contrary, each Party will be responsible for its own costs and expenses in establishing and conducting programmes and activities contemplated under this MOU.

Article 5

This MOU shall take effect after it has been signed by both parties on the last date of signature and shall continue to be effective for a period of five (5) years, renewable automatically for an identical period, if neither party notifies in writing the other of a desire to terminate the Agreement at least six (6) months prior to the concluding date.

The provisions of this MOU, in respect of any on-going exchange programme or any other form of cooperative activity under this MOU, shall continue to apply until the completion of said programme or activity, unless both Parties mutually agree in writing to the earlier termination of the programme or activity.

Article 6

This MOU is written and signed by the duly authorized representatives in two duplicate copies in English, with each of the copies being equally authentic.

Each Party will be responsible for any fiscal charge related to the execution of this MOU, according to the rules and regulations applicable in each institution.


